Schedule will be provided. Bitches in season will be allowed but will be moved to the end of the class in tests and in catalog order in trials. Please notify the Event Secretary if your bitch is in season.

ALL AMERICAN KENNEL CLUB RULES REGARDING CONDUCT WILL BE STRICTLY ENFORCED. No refund for duplicate entries or any other cause beyond the control of the club after closing of entries. RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY. NO CONDITIONAL ENTRIES WILL BE ACCEPTED. **ENTRY FORMS MUST BE SIGNED.** A separate entry form must be completed for each dog entered. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side of the Official AKC Entry Forms are NOT ACCEPTABLE.

Owners or their Agents are solely responsible for the presence of their dog(s) at the test/trial arena. Judges are not required to wait for dogs. Entry fees shall not be refunded in the event that a dog is absent (unless replaced by an Alternate), disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, fire, act of God, public emergency or other acts beyond the control of the Club it is impossible to open or to complete the test/trial, no refund of entry fee will be made. Exhibitors are responsible for keeping their dogs leashed and under control at all times and MUST clean up after their dogs. PLEASE HELP US KEEP THIS SITE CLEAN. USE TRASH CANS ON THE PREMISES.

ALL ENTRIES SENT VIA FED EX OR EXPRESS MAIL MUST HAVE SIGNATURE WAIVED Entries close at Secretary's office 4:00 PM June 6, 2018 after which time entries cannot be accepted, canceled, altered or substituted. 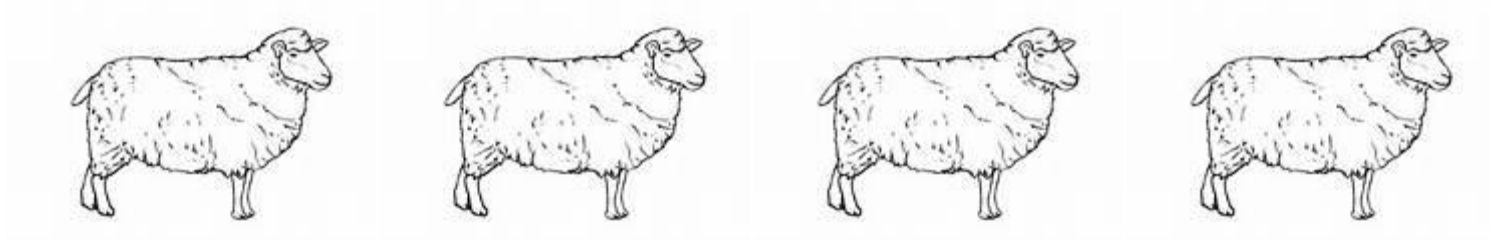
Directions to Test/Trial Location

Directions to Trial Site: From I-35 go east on Mn Hwy 97. Go east for 14.5 miles to Lofton. Turn left for 2.5 miles to 238th St. Turn right for 1 mile to Morgan. Turn left for 1 mile. Farm is on the right.

Veterinarian (on call) Oakdale Emergency Clinic,
1163 Helmo Ave. No., Oakdale, MN 55128 1-651-501-3766

Directions: From Trial site, turn left Morgan and go 1 mile to 238th St. Turn right for 1 mile to Lofton. Turn left for 2.5 miles to MN 97 – go 1.4 miles. Turn left onto Manning Trl (CR15) – go 15.6 miles south. Turn right on Hwy 36 – go 5.1 miles. Take the I694 S ramp – go .2 miles merge onto I-694 E – go 4.4 miles. Take the 10th St exit (#57). Left on 10th St – go .4 miles. Left onto Helmo Ave N – go .3 miles. Look for the blue and white sign on the right Animal Emergency Clinic.
